The application process is entirely free.

- ✓ Select a maximum of two degree programmes
- ✓ Fill in an online application in your personal account
- ✓ Upload your portfolio
- ✓ Wait for the results in your personal account (within two weeks) and provide your consent for studies
- ✓ Submit necessary documents (Step 4 at admissions.hse.ru/en)

To be eligible for HSE University's scholarships, you must receive a minimum grade of 55 points on your portfolio assessment.



Deadline for submitting applications for respective competitions for international applicants is **by August 13, 2023**.

Please note that you need to upload your portfolio to your personal account **before August 13, 2023** (or, to receive a scholarship – before April 1, 2023).

Start of academic year is **September 1, 2023** (or October 1 for certain programmes).
